UNITED STATES INTERNET MINIMUM ADVERTISED PRICE POLICY
Effective Date: January 1, 2023

Weleda, Inc. (“Weleda”), has determined that certain advertising practices undermine Weleda’s trade reputation, brand, and premium image within the target consumer population and discourage Weleda’s resellers from investing in the Weleda product lines and providing the best possible service and support to consumers. Accordingly, to protect the integrity of the Weleda brand, Weleda has adopted this unilateral Internet Minimum Advertised Price Policy (the “Policy”), which applies to all authorized Internet resellers of Weleda Products in the United States of America.

The Policy applies to online advertisements of the Weleda products listed on the Weleda MAP Schedule (“Covered Products”). The Weleda MAP Schedule will be made available to all resellers and may be amended by Weleda in its sole discretion at any time.

Weleda is solely responsible for establishing the minimum advertised price (“MAP”) for each Covered Product and communicating the MAP to all resellers. While resellers remain free to advertise and sell all Weleda Products at any price they deem appropriate, it is a violation of this Policy for a reseller to advertise any Covered Product online at a price lower than the MAP. Such advertisements include, but are not limited to:

- i. Offering coupons, discounts, reseller rebates, or other inducements that, when applied, result in a price lower than the MAP, including through use of a storewide sale, promotional code, or other similar provision that can be applied to Covered Products.
- ii. Other than bundles authorized by Weleda and sold under a specific SKU designated by Weleda, bundling Covered Products with other products or services (whether made by or provided by Weleda or another entity) in a manner that implies below-MAP pricing for the bundled Covered Product.
- iii. Strikeouts or strikethroughs of pricing information, “see price in cart,” or other statements that suggest that a lower price for a Covered Product may be found at the final online checkout stage.
- iv. Permitting any third-party to alter the advertised price for any Covered Product.

Direct or indirect attempts to circumvent this Policy also violate this Policy; however, it is not a violation to advertise that a customer may “call for price,” “text for price,” or “email for price” as long as no price is listed and no automated call, text message, or “bounce-back” email is used in response.

For purposes of this Policy, the terms “advertise” and “advertisement” include all promotional or pricing information displayed on any and all websites, blogs, social media, affiliate marketing networks/comparison shopping engines, reseller-initiated text messages or emails to customers or prospective customers, instant messaging, mobile/smart phone applications, banner ads, online product ads, paid search ads, pay-per-click ads, display ads, mobile ads, product-listing ads,

sponsored links, ads in any other media in a digital format that is communicated or conveyed via the Internet.

Notwithstanding the foregoing, pricing information displayed at the final online checkout stage of a transaction is not considered “advertising” under this Policy. The “final online checkout stage” is the stage when the Covered Product is put into a shopping cart that contains the customer’s name, shipping address, email address, and payment information. Pricing information in the “shopping cart” or “checkout” stages must be obscured technically so that it is not retrievable by shopping and pricing engines, and not displayed on search page results within the reseller’s own website.

From time to time, Weleda may announce iMAP holidays or promotions that are applicable to all resellers, during which periods a reseller that advertises a Covered Product in accordance with the terms of the authorized promotion will not be deemed to have violated the Policy. Weleda will notify all resellers of any such authorized promotions, generally not fewer than 30 days in advance.

Further, the advertisement of free or reduced-price shipping is not a violation of this Policy as long as such offer applies to all or almost all other products offered by a reseller in the same product category.

This Policy does not constitute an agreement between Weleda and any other entity. Weleda neither solicits nor will it accept any assurance of compliance with this Policy from any reseller or other party. Each reseller must independently choose whether to comply with the terms of this Policy. This Policy is not negotiable and will not be altered for any individual reseller. This Policy applies only to advertised prices and does not affect the prices that a reseller may charge for Weleda Products.

NON-COMPLIANCE

Weleda will take the following actions against any Internet reseller that fails to comply with this Policy with respect to the advertisement of any Covered Product:

- i. For a reseller’s first violation of the Policy, Weleda will notify the reseller in writing of such failure. If the violation continues for more than thirty (30) days, the continuing violation shall be deemed the reseller’s second violation of the Policy.
- ii. For a reseller’s second violation of the Policy, Weleda will notify the reseller in writing of such failure and will immediately revoke reseller’s “authorized” status for thirty (30) days, and if reseller purchases directly from Weleda, will immediately place the reseller’s account on shipping hold for thirty (30) days and revoke its acceptance of any pending orders, cancel any pending shipments to the reseller, and not accept any new orders from reseller during this 30-day period.
- iii. For a reseller’s third violation of the Policy during a 12-month period following the first violation, Weleda will notify the reseller in writing of such failure and will immediately revoke reseller’s “authorized” status for ninety (90) days, and if reseller purchases directly from Weleda, will immediately place the reseller’s account on shipping hold for ninety (90) days and revoke its acceptance of any pending orders,

cancel any pending shipments to the reseller, and not accept any new orders from reseller during this 90-day period.

- iv. For a reseller's fourth violation of the Policy during a 12-month period following the first violation, Weleda will revoke reseller's "authorized" status, and if reseller purchases directly from Weleda, terminate its business relationship with the reseller and revoke its acceptance of any pending orders and cancel any pending shipments to the reseller.

The Policy will be enforced by Weleda in its sole discretion and without notice. Resellers have no right to enforce the Policy.

POLICY ADMINISTRATION

Weleda may update, revise, suspend, terminate, reinstitute, or modify this Policy at any time in its sole discretion. Weleda shall make any such modifications available to all authorized resellers. If Weleda changes the MAP on any Product, it will provide at least 14 days' notice to resellers before such change takes effect.

No Weleda employee or agent, including a reseller's sales representative, is authorized to modify, interpret, or grant exceptions to this Policy; solicit or obtain the agreement of any person to this Policy; or otherwise discuss any aspect of this Policy with any reseller, including that reseller's or any other reseller's compliance with the terms of the Policy. Any questions about this Policy should be submitted in writing and directed to Weleda's MAP Policy Administrator at PolicyAdmin@Weleda.com. Weleda will accept no other form of communication from resellers regarding the Policy.

This Policy is effective January 1, 2023 and supersedes all prior Weleda policies and/or representations regarding minimum advertised prices or resale prices for Weleda Products applicable to any reseller. To the extent that any provision, term, or agreement governing the relationship between Weleda and any reseller may be construed in a manner that is inconsistent with the terms of this Policy, the terms of this Policy control.

For a reseller’s second violation of the Policy, Weleda will notify the reseller in writing of such failure and will immediately revoke reseller’s “authorized” status for thirty (30) days, and if reseller purchases directly from Weleda, will immediately place the reseller’s account on shipping hold for thirty (30) days and revoke its acceptance of any pending orders, cancel any pending shipments to the reseller, and not accept any new orders from reseller during this 30-day period.
- iii. For a reseller’s third violation of the Policy during a 12-month period following the first violation, Weleda will notify the reseller in writing of such failure and will immediately revoke reseller’s “authorized” status for ninety (90) days, and if reseller purchases directly from Weleda, will immediately place the reseller’s account on shipping hold for ninety (90) days and revoke its acceptance of any pending orders,

cancel any pending shipments to the reseller, and not accept any new orders from reseller during this 90-day period.

- iv. For a reseller's fourth violation of the Policy during a 12-month period following the first violation, Weleda will revoke reseller's "authorized" status, and if reseller purchases directly from Weleda, terminate its business relationship with the reseller and revoke its acceptance of any pending orders and cancel any pending shipments to the reseller.

The Policy will be enforced by Weleda in its sole discretion and without notice. Resellers have no right to enforce the Policy.

POLICY ADMINISTRATION

Weleda may update, revise, suspend, terminate, reinstitute, or modify this Policy at any time in its sole discretion. Weleda shall make any such modifications available to all authorized resellers. If Weleda changes the MAP on any Product, it will provide at least 14 days' notice to resellers before such change takes effect.

No Weleda employee or agent, including a reseller's sales representative, is authorized to modify, interpret, or grant exceptions to this Policy; solicit or obtain the agreement of any person to this Policy; or otherwise discuss any aspect of this Policy with any reseller, including that reseller's or any other reseller's compliance with the terms of the Policy. Any questions about this Policy should be submitted in writing and directed to Weleda's MAP Policy Administrator at PolicyAdmin@Weleda.com. Weleda will accept no other form of communication from resellers regarding the Policy.

This Policy is effective January 1, 2023 and supersedes all prior Weleda policies and/or representations regarding minimum advertised prices or resale prices for Weleda Products applicable to any reseller.
