USE THIS FORM:

1. If Leo member was not reported to Lions International, this form must be submitted to memberservicecenter@lionsclubs.org to request to add credit for their Leo years of service to their Lion record. If the former Leo is chartering a new Lions club, this form must also be submitted to newclubs@lionsclubs.org.
2. If Leo member was reported to Lions International, use this form to collect information needed to complete the required fields in the Lion Portal to transfer a current or former Leo to a Lions club. **Keep this worksheet for Lions club records.** This form should not be submitted to Lions International if the data is entered in the Lion Portal.

In areas not using the Lion Portal, this form may be submitted to memberservicecenter@lionsclubs.org to choose to waive the international dues discount. Credit for Leo years of service will be automatically added to the Lion record from the required Leo start date entered in the Lion Portal.

LEO-LION DISCOUNTS
