



Domestic eCommerce Agreement

Amazon Policy

Rockhouse Industries, Inc. (manufacturer of Piggy Paint, SOPHi, and Rock the Locks) is the exclusive, authorized seller of our brands in the Amazon US Marketplace. As such, resale of Piggy Paint, SOPHi, or Rock the Locks branded products in the Amazon Marketplace, by any entity other than Rockhouse Industries, Inc. or our designee, is prohibited.

Other eCommerce Channels

The resale of Piggy Paint, SOPHi, and Rock the Locks branded products is permitted on other eCommerce platforms (outside of Amazon US).

Any retailer wanting to sell Piggy Paint branded products on-line must be approved by Piggy Paint, LLC and agree to the terms of this agreement.

Authorized retailers are solely responsible to ensure that the information displayed on their website(s) is correct.

Approved vendors will make no statements on behalf of Piggy Paint, LLC, and company's website or social media outlets will not give the impression that the company is a part of or endorsed by Piggy Paint, LLC.

The retailer is solely responsible for all consumer returns. Any defective or damaged goods need to be returned to Piggy Paint, LLC upon arrival of order, before goods are shipped to the consumer.

Retailer agrees to comply with Piggy Paint, LLC's Minimum Advertised Price ("MAP"), which is:

- Piggy Paint products cannot be searchable for any price less than the above.
- Piggy Paint LLC reserves the right to change MAP by providing written, 60 day notification to retailers.

- 3 Polish + Nail Art gift set: \$13.99 each
- 2 Polish + 3.4 oz. remover + Nail Art gift set: \$14.99 each

0.12 oz. Nail Polish Sets

- Individual sale of 0.12 oz. bottle is not permitted
- 4 Polish Boxed Set (scented or barn box): \$13.99 each
- 2 Polish + 2 oz. Remover Boxed Set: \$10.99 each
- Lil' Glam Girl: \$12.99 each
- Mini Mani Kit: \$9.99 each

Any deviation from this policy will constitute a violation of this policy and Piggy Paint LLC will take all legal action to ensure compliance. When a retailer is notified of a violation, they will have 48 hours to correct the issue before additional action will be taken, up to and including suspension or account termination. Piggy Paint, LLC reserves the right to terminate business with any retailer at our discretion with written 48-hour notification.

The MAP policy applies to all advertisements of Piggy Paint branded products in any and all media, including, but not limited to, online stores, blogs, internet advertisements, and email solicitations.

If pricing is displayed, any strike-through or other alteration of the Minimum Advertised Price is prohibited.

Retailer agrees to hold all trademarks of Piggy Paint LLC as the property of Piggy Paint LLC and use advertising materials provided by Piggy Paint LLC in an authorized manner only.

Retailers must manage their business and inventory independently and find the need to promote specific items. Any product identified by Piggy Paint LLC, as discontinued or closed-out can be advertised and searched at whatever price the retailer deems appropriate as long as the product is not represented as an every-day price and is clearly identified as discontinued or closed-out.

Upon execution of this Agreement, Piggy Paint grants to retailer a limited, non-exclusive, non-transferable license to display on Retailer's retail website, subject to Piggy Paint approval, certain Piggy Paint trademarks and related logos, tag lines, text, graphics, logos, icons, and images ("Piggy Paint Content"). Upon request, Piggy Paint will provide retailer with the necessary graphical representations and use explanations regarding the Piggy Paint Content. Retailer acquires no right or interest in the Piggy Paint Content except as a licensed user. In no way does this Agreement limit Piggy Paint LLC's right to use any of the Piggy Paint Content online or elsewhere.
